Notice of Decision of Matters Concerning Acquisition of Own Shares (Acquisition of Own Shares pursuant to the Provisions of the Articles of Incorporation as Stipulated in Article 165, Paragraph 2 of the Companies Act)

House Foods Group Inc. (the "Company") announces that at a meeting of its Board of Directors held on May 11, 2021, it resolved matters concerning the acquisition of own shares pursuant to the provisions of Article 156 of the Companies Act that are applied by replacing terms pursuant to the provisions of Article 165, Paragraph 3 of the Act. The Company will acquire its own shares to execute the capital policy in response to changes in the business environment and strive to improve capital efficiency and enhance shareholder returns.
