Notice of Purchase of Own Shares in Off-Floor Trading for Company's Own Shares (ToSTNeT-3)

House Foods Group Inc. (the "Company") announces that at a meeting of its Board of Directors held on May 11, 2022, it resolved to acquire its own shares pursuant to the provisions of Article 156 of the Companies Act that are applied by replacing terms pursuant to the provisions of Article 165, Paragraph 3 of the Act, and the Company has decided a specific acquisition method of part of the own shares. Details are as follows.

1. Acquisition method

The Company will entrust the purchase in off-floor trading for company's own shares (ToSTNeT-3) of the Tokyo Stock Exchange at 8:45 a.m. on May 12, 2022 at the closing price of 2,995 yen today (May 11, 2022) (changes to other trading systems or another trading time will not be made).

The said buy order is an order limited to the said trading time.
